With consent of the government I write to request an adjournment of the status conference in this case, which is currently scheduled for April 17, 2018 at 11:15 AM. I am currently on trial in front of Judge Kaplan in United States v. David Blaszcak, 17Cr. 357, which is expected to continue for the next one to two weeks. I seek an adjournment of the status conference to any Friday after 2 p.m., or any date after my trial is expected to conclude in two weeks.
